Dear Parents,

You might recall that I first met with you on the evening of our October 1st "Back to School Night. We gathered on the front deck in very favorable weather and I introduced a few ideas about Odyssey School's bright future while also communicating the annual theme for that year.

Discussion of Packing List

This is a complement to the attached packing list, with advice on packing and what kind of equipment to buy.

When gathering supplies, please be mindful of the following:

Don't buy anything new if you can help it! There should only be one item you will need to buy, and that is the **down jacket** you will use for the cold conditions on Mt. Fuji. Please take advantage of the wonderful Odyssey community and borrow any items (such as luggage) that you don't already own.

Less is better. Pack only what is on the packing list. Students will be responsible for carrying all of their own luggage. Heavy or unwieldy luggage places a burden on the group as a whole.

Use Ziploc bags in order to compartmentalize different items such as underwear, socks, and shirts. Students are expected to pack ad repack bags every night. Ziploc bags will also protect from water damage.

Bags:

• Main Bag: All students need a main luggage bag. This bag should be as small and allow for as much mobility as possible. A carry-on sized roller bag is highly recommended. You can find examples of good bags below, all of which came priced at \$23 to \$40. The dimensions of these are roughly 22" x 14" x 9." If you think you have something suitable already, by all means check with Odyssey staff.



Day Pack: This should be like a typical backpack for school. The daypack should be comfortable – remember you are climbing a mountain with it on your back! Criteria include: adjustable straps, big enough to hold all the items indicated for "day pack" in the pack list, and outside pockets to allow quick access to a change purse or water. No wheels or messenger-style bags.

Clothing:

- Under-clothing should be easy to wash and hang-dry.
- Uniform clothes/Other clothes notes: Odyssey will provide colored Odyssey collared shirts, an Odyssey windbreaker, and Odyssey fleece. Students will be asked to bring their own Odyssey "movement clothes." Students will be wearing khaki pants as part of their uniform – these pants must not be low-rise as students need to be able to tuck in their shirts. One pair of the Khaki pants can be shorts with at least a 6-inch inseam, or a knee-length skirt.
- Slippers: Students whose shoe-size is over men size 10 are asked to bring their own inside slippers as most accommodations will not carry larger sizes.

- Down Jacket: All students are required to purchase a Uniglo "Water Defender Ultra Light Down (Navy)" These can be found easily on the Uniglo website or at the Uniqlo store locations (Hillsdale, San Francisco, Milpitas, San Jose) Either the men's or the women's version is fine. These jackets are perfect for our needs on Mt. Fuji.
- Cultural appropriateness: Japanese people tend to cover their shoulders, so we ask students to not bring tank tops. Likewise, we ask that students not bring make-up as it is inappropriate for their age group on a school trip.

Gifts:

• For homestay families: It is customary to bring a gift with you when visiting a home in Japan. Since Japanese houses are small and tend to get cluttered easily, it's best to give something consumable. Goods that you can only find in America are the best ideas. Do not give a gift with an even number of items (like a set of 4 postcards) – keep your numbers odd! Gifts should always be wrapped as nicely as possible. Keep your gift nice, but do not shame your homestay family with an overly expensive gift.



It's better to have something brightly

• Special gift for your homestay: Shinonome host students are around the same age as an Odyssey student, and Tokiwagi students are significantly older (16/17 years old), but both will be interested and excited in anything very culturally American. Small memorabilia with English phrases or sports team logos, cute American stationary, a mix CD with music you like – these are thoughtful gifts that reflect your personality without being too over-the-top or culturally insensitive in any way.



Go Giants!

• Small Travel Gifts: Students will want to give something small to the many people who will have helped them. Things like your calling cards, stickers, bookmarks, or even candy are easy to carry around.

Other Items:

- Camera: A disposable camera works, as well as a digital camera. Make sure to bring a charger with a two-pronged wall plug.
- Pack-Towel: This is a small camping towel you can find at REI.
- Feminine products: You may find these items in convenience stores in Japan, but many find American versions to be more familiar/comfortable



School-related items:

- Japan Journal: This is a new journal you will purchase specifically for the trip and write in regularly. Details to be provided on a separate sheet in social studies class.
- Course Pack: This is reading material for the trip a collection of short stories, activities and thoughtful essays on Japanese culture to add breadth to your experience in Japan. Students will receive this at the Airport.
- Money: Odyssey covers all trip expenses. Students should bring \$300 in yen for: snacks, drinks, independent activities, and treating host families to dinner. Please have students come with their money in two envelopes with their name and the dollar amount on each envelope. The envelopes should have \$150 each in YEN. Teachers will keep track of student spending money.

- **7. Voluntary Release of All Claims:** I/We voluntarily release, discharge, waive, and relinquish all claims against the School, its officers, directors, trustees, volunteers and employees arising out of or in any way related to the above described activities, including but not limited to, claims for bodily injury, personal injury, emotional distress, property damage or wrongful death occurring to the Student arising out of ordinary negligence during the course of the Field Trip. This release, discharge, waiver and relinquishment also pertains to any instruction or supervision related to the Field Trip on the part of the School, its officers, directors, trustees, volunteers and employees.
- **8.** Release from Third-Party Liability: I/We understand that the School is not an agent of, and has no responsibility for, any third party including without limitation any sponsor or program that may provide any services, equipment, training or activities associated with the above mentioned Field Trip. We do not anticipate using any third party providers of services, equipment, training or activities while on Expedition Japan.
- **9. Indemnification:** The Student and his/her parent(s)/guardian(s) further agree to defend and indemnify the School, its officers, directors, trustees, volunteers and, employees for any action or claim commenced by parent(s)/guardian(s) or on behalf of parent(s)/guardian(s), or for any action commenced by the Student or on behalf of the Student, arising out of or in any way related to the above described Field Trip, including but not limited to a claim for bodily injury,

personal injury, emotional distress, property damage and/or wrongful death arising out of ordinary negligence during the course of the Field Trip.

- **10.** Pre-Existing Medical Condition of Student: I/We release School and its officers, directors, trustees, volunteers, and employees from all claims and liability for any illness, injury, loss of property and/or death resulting during or after the program from a pre-existing medical (physical, emotional and/or psychological) condition of the Student. I/We have read and completed fully confidential medical forms provided by School at the beginning of the school year. I/We accept full responsibility for omissions or errors on the medical information form. To the best of my/our knowledge, the Student has no medical (physical, emotional or psychological) conditions that would interfere with his/her ability to participate in the Field Trip or would otherwise endanger his/her health while participating in this program.
- 11. <u>Medical Care</u>: Any School officer, director, trustee, volunteer, or employee is authorized to obtain immediate medical attention for Student. I/We consent to whatever examination, x-ray, anesthetic, medical, surgical or dental diagnosis or treatment and hospital care are considered necessary in the best judgment of the attending physician, surgeon or dentist and performed by or under the supervision of the medical staff of the hospital or facility furnishing medical or dental services
- **12.** Photo or Likeness of Students are School Property: I/We understand that photographs, video or likenesses of Student become the property of School who may use the photographs for publicity purposes such as in School publications, promotions or the School website.
- **13.** <u>Severability</u>: If any provision of this Permission, Waiver, Release, and Indemnity Agreement is held to be invalid or unenforceable, the remainder of this agreement shall nevertheless remain in full force and effect.
- **14.** Entire Agreement: This Permission, Waiver, Release, and Indemnity Agreement constitutes a single, integrated contract expressing the entire agreement of the parties hereto. There are no other agreements, written or oral, express or implied, between the parties, concerning Expedition Japan, except this agreement. This Permission, Waiver, Release, and Indemnity Agreement may be modified or superseded only in a written instrument to this agreement that specifically references this Permission, Waiver, Release, and Indemnity Agreement and is executed by all parties.
- **15.** <u>Voluntary Agreement</u>: Student and the parent(s)/guardian(s) acknowledge that they have read this Permission, Waiver, Release, and Indemnity Agreement and are aware of the legal consequences of signing this binding document.

I/We have taken steps to become informed about the Field Trip and certify that I/we are satisfied with the nature and quality of the Field Trip as a voluntary activity for the student. I/We have read this Permission, Waiver, Release, and Indemnity Agreement. I/We understand that signing this agreement is voluntary and that I/we have been given the

opportunity to seek legal counsel and to question Stephen Lane before signing this binding document.
